## BULK PACK SPECIFICATIONS:

Packaged in a food grade corrugated box. Boxes have a food grade Michelman coated inside with a food grade dry coated parchment paper placed on the top and bottom of each box. Box closures are taped and sealed top and bottom. Product has the option to be packed in a food grade vacuum blue sealed bag. Vacuum packing adds an additional layer of protection from odorous foods a barrier to insects, airborne contamination and product moisture absorption. There is also a presentation of bags stand pouch.

Markings on the carton include Product description, Product Code, Lot Number, Manufacturing Date, Serial Number, Pallet number and Net weight of the item.

For Corrugated boxes 30 lbs are palletized on a standard 48"x40" standard GMA pallet with a stack pattern of 10 boxes per layer by 6 boxes high, column and staggered stack pattern.

Approximate fully stacked dimensions are: 48"x40"x72

# STORAGE AND HANDLING CONDITIONS:

Store in cool dry hygienic environment away from strong odors.

Shelf life: recommended temperature conditions from 33F to 40F for 1 year or less.

Optional conditions: < 0F for 2 years or less.

IMPORTANT NOTE: In case of modifying these parameters, the records keeping time policy shall be revised according to the Laws and the SQF Code.
